**Subject: Product Declaration – REACH Compliance**

Dear Valued Customer:

REACH is a European Union (EU) regulation on chemicals and the safe use of products. It deals with the **R**egistration, **E**valuation, **A**uthorization and restriction of **C**hemicals (EC 1907/2006), effective on June 1, 2007.

As a company committed to superior product stewardship, Formosa Plastics Corporation, U.S.A. (FPC USA) complies with the current requirements of REACH. Since Formosa does not manufacture in the EU; our "Only Representative" (OR) fulfills this responsibility. In general, our responsibility is to register designated substances used to produce our resin products, not the resin products and not any mixtures or "articles" made from them.

In August 2008, through our OR we pre-registered monomers and other substances used in the production of our resins. We also registered other substances that exceed the 100 ton/year threshold prior to the June 1, 2013 deadline. Substances in the 10-100 and 1-10 bands were pre-registered prior to May 31, 2017 deadline. Final substance registrations were fully submitted prior to the May 31, 2018 deadline.

It is FPC USA's policy to provide substance registration numbers only to EU customers that purchase (import) registered substances (e.g. Caustic Soda 50%) directly from FPC USA. **If a customer or distributor wishes to sell to companies in the EU, they must assume full responsibility for REACH registration and other applicable regulatory requirements for their respective products and sales.**

Formosa continues to work with the supply chain, our suppliers and customers to communicate important information related to REACH and its requirements. In addition, we revised all of our product Safety Data Sheets in accordance with the Globally Harmonized System (GHS) and made changes related to relevant exposure scenarios for certain substances of concern, where applicable.

**A Note on Substances of Very High Concern (SVHC):** Article 33.1 of the REACH regulation states that *'manufacturers and importers of articles (products) are required to notify their customers of the presence of any Substances of Very High Concern in their products exceeding 0.1% by weight.'* Our *REACH SVHC Product Declaration Letter*, available on the "Products" section of our website, provides our notification on this matter.
